Engineer:

415 Award and enter into a contract with Leiby Construction Inc of West Salem, Ohio in the amount of \$71,031.00 for the West North Street Drainage Improvement Project in Rochester Village. 5 bids were received with this being the most responsive complying with specifications. Work consists of removing and replacing approximately 330 ft of storm sewer along West North Street. Issue Notice to Proceed upon full execution of the contract and the work will be completed on or before December 1, 2025. OPWC will provide \$38,356.74 and remaining funds will be provided from Acct#engineer projects in the amount of \$32,674.26. The Village of Rochester will reimburse the Engineer's Office for 100% of the remaining project costs, upon the completion of the project. Authorize Administrator to notify The County Auditor to release retainage at the completion of the project.
