- #5. Black River Area of Concern Shows Significant Improvement. USEPA has approved the removal of the Degradation of Fish and Wildlife Populations and Loss of Fish and Wildlife Habitat Beneficial Use Impairments (BUIs) from the Black River Area of Concern (AOC). The Black River AOC Advisory Committee originally identified nine BUIs that needed to be addressed. The Degradation of Fish and Wildlife Populations and Loss of Fish and Wildlife Habitat impairments are the seventh and eighth BUIs that have been removed due to investments and improvements made in the AOC. The Ohio Lake Erie Commission and Ohio EPA continue to work towards the removal of the remaining BUI with local AOC partners.
